



## SELECTION POLICY FOR HANGZHOU 2022 ASIAN GAMES

10 - 25 SEPTEMBER 2022

### **1. EVENTS**

The draft proposal of Hangzhou 2022 Asian Games, which will be held from 10 September 2022 - 25 September 2022.

### **2. GOALS & OBJECTIVES**

To achieve top 16 position in the events contested.

### **3. SELECTION COMMITTEE**

The selection committee will consist of the following members:

- 1) Breaking Lead operating under SGDF
- 2) Head Coach (Breaking representative under SGDF)

### **4. ELIGIBILITY AND CONSIDERATION PERIOD**

- i. For ease of documentation, the consideration period will be from 10th December 2021 to 25th May 2022.
- ii. All athletes must maintain their membership with the Singapore DanceSport Federation (SGDF during the period of consideration stated in (i)).
- iii. All athletes to be considered for Hangzhou 2022 Asian Games must be Singapore Citizens at the time of nomination and must not hold dual citizenship if they are above 21 years old at the time of nomination; and fulfill the eligibility under the regulations from the DanceSportAsia (DSA).
- iv. To date, most breaking competitions lack an official, centralised institution or federation to verify results. As breaking continues to gain international recognition as a competitive event, the selection committee foresees corresponding changes in the way breaking competitions are organised and verified. To work around present limitations, the selection committee puts forth a short-term selection policy that accommodates for the lack of the sustained presence of a local breaking federation, especially since the covid-19 situation has put all events on halt in 2020 till date.
- v. Athletes keen on being selected as a Hangzhou 2022 Asian Games representative have to compete in 3 National Ranking Events (date to be decided).
- vi. The selection committee will take responsibility in verifying the results of the ranking events.

## **5. SELECTION CRITERIA**

- i. All interested athletes are to participate in the National Ranking Events.
- ii. The scores will be tabulated at the end of the 3 National Ranking Events (Event 1 points + Event 2 points + Event 3 points).
- iii. 4 athletes (2 from each category) with the highest points will be nominated for consideration.
- iv. The following table displays the points awarded for each place per event:

Placing	1st	2nd	3rd
Points	5	4	3

## **6. OTHER CONSIDERATIONS**

In addition to the above selection criteria, the following “qualities” of the athletes will be taken into consideration:

- Attitude and behavior towards coaches, teammates, fellow athletes, officials and sports administrators, whether in relation to sporting matters or otherwise.
- General conduct and character which may affect the reputation, image, values or best interests of the athlete or the sport.
- Past disciplinary record;
- Current skill level and fitness; and character
- Level of commitment and attendance.
- Potential for future development;
- Ability to demonstrate team spirit and work well with teammates and officials; and such other non-performance related qualities as the selectors may consider to be relevant.

## **7. SELECTION PROCESS**

- i. The selection policy will be published at [www.dancesport.org.sg](http://www.dancesport.org.sg) prior to conducting any National Ranking Event.
- ii. Two weeks before the deadline for submission to SNOC, the Selection Committee meeting will be convened to select the players based on the above criteria.
- iii. Athletes who are selected for the Hangzhou 2022 Asian Games have to fulfil all training requirements set by the National Coaches and Selection Committee.

## **8. APPEAL PROCESS**

- i. Appeal against non-nomination by SGDF must be made in writing to SGDF Administrators within 48 hours of the announcement of nominees.
- ii. An appeal must be made in writing with supporting documentation if any.

- iii. An appeal would only be considered if the athlete had met the eligibility criteria and minimum qualification requirements for the sport, but was not nominated due to gross oversight by SGDF. SGDF's Committee will deliberate the appeal and, if deemed justifiable, hear the appeal by the athlete concerned.
- iv. SGDF will, in writing, inform all parties about the decision taken to either uphold or reject the appeal. The decision will be final and no further correspondence will be entertained.

## **9. CODE OF CONDUCT**

- i. The contingent is under the management of the Chef De Mission (CDM) and SNOc during the games. If there are any disciplinary issues, the Team Manager should inform the CDM/SNOc. An SNOc Disciplinary Committee will be convened, if necessary.

We will hold 3 National Ranking Event dates to be advised.

In the event that events are not available due to COVID19, the following list (not exhaustive) will constitute the minimum selection criteria:

- Latest ranking used (including those for SEAG19 Clark)
- Carding status – this is to ensure that athletes maintain a training programme during COVID19
- President and Coach will verify the training programme – to maintain a minimum level of competitive performance
