

## SELECTION POLICY FOR SOUTH-EAST ASIA (SEA) GAMES 2023 5 MAY TO 16 MAY 2023

#### 1. EVENT

The draft proposal for SEA Games 2023, which will be held in Phnom Penh, Cambodia from 5 May to 16 May 2023, states that each National Olympic Council (NOC) in South-East Asia may send a maximum of 1 male & 1 female (2 athletes) and each athlete may participate in a maximum of 1 event each.

#### 2. GOALS & OBJECTIVES

To attain a medal (min. Bronze) in the event(s) contested.

## 3. SELECTION COMMITTEE

The selection committee will consist of the following members:

- 1) Singapore DanceSport Federation (SGDF) President
- 2) Breaking committee under SGDF

## **4. ELIGIBILITY AND CONSIDERATION PERIOD**

- i. Due to the lack of participation in any WDSF (World DanceSport Federation) sanctioned breaking event and the absence of Breaking events in SEAG2021, the Breaking committee puts forth the following selection policy with considerations to the Singapore National Olympic Council's (SNOC) Selection Policy.
- ii. Consideration dates are from 1 April 2022 to 15 February 2023.
- iii. All achievements submitted should have taken place at WDSF sanctioned events as listed in the SNOC Selection Policy.
- iv. As the Games are organized under the auspices of the World DanceSport Federation (WDSF) and DanceSportAsia (DSA), participation in any events outside of WDSF and DSA system during (ii) will result in disqualification. However, this is subjected to the approval of SGDF.
- v. Athletes to be considered for the SEA Games must be Singapore Citizens (and should not be holding dual nationality, if they are above 21 years old), at the time of nomination.
- vi. All athletes keen on being selected as a SEA Games 2023 representative must be a registered member of SGDF, must maintain valid SGDF membership till SEA Games 2023, and must be a valid member of the WDSF and have a valid MIN number.

## **5. SELECTION CRITERIA**

- i. 2 male and 2 female athletes will be nominated for consideration by the Selection Committee of SNOC.
- ii. Only athletes that fulfil the eligibility (4) will be considered for nomination.
- iii. All achievements submitted for consideration should be achieved within a 12-month period before SEAG2023 (i.e., 1st April 2022 to 15 February 2023).
- iv. SNOC's selection criteria requires athletes to have achieved or demonstrated at least 3<sup>rd</sup> placing in SEAG2021. However, as there was no Breaking event during the SEAG2021, all achievements submitted for consideration <u>must</u> demonstrate athletes achieving at least 3<sup>rd</sup> placing in competitions involving Southeast Asia competitors (Please see Annex A).

## **6. OTHER CONSIDERATIONS**

- i. In addition to the above selection criteria, the following will also be taken into consideration:
  - a. General conduct and character which may tarnish the reputation, image, values or best interests of the athlete or the sport.
  - b. Current skill level and fitness (depending on the above achievements)
  - c. Level of commitment
  - d. Past disciplinary records (if any)
  - e. Attitude and behavior towards the administrators and committee members of SGDF.

#### 7. CODE OF CONDUCT

i. If athletes exhibit any form of ill-behavior during the SEA Games 2023 that maybe considered as detrimental to the image of the Singapore Team, or if there are any infringements of the Team Membership Agreement, the athlete's punishment will be made by SNOC/CDM.

## 8. APPEAL PROCESS

- i. Appeal against non-selection must be made in writing, with supporting documentation and accompanied by a deposit of S\$100.00 payable to Singapore DanceSport Federation, to President (SGDF) at PO Box 0280 Tanjong Pagar Post Office, Singapore 910810, or email the breaking committee at bboy.dyng@gmail.com within 48 hours of the announcement of selected players for the SEA Games. If the appeal is successful, the deposit will be refunded in full.
- ii. The only ground for consideration of appeal is if the selection process was not properly followed.
- iii. An appeal would only be considered if the athlete had met the eligibility criteria and minimum qualification requirements for the sport but was not nominated due to gross oversight by the Breaking Committee. The Breaking Committee will deliberate the appeal and, if deemed justifiable, hear the appeal by the athlete concerned with the advisement from SGDF.
- iv. An Appeal Committee (consisting of members not directly involved in the selection of the athletes) will be nominated and assembled to investigate the issues of the appeal with all involved parties to determine the validity of appeal.
- v. The Breaking Committee will, in writing, inform all parties about the decision taken to either uphold or reject the appeal. The Appeal Committee's decision will be final, and no further correspondence will be entertained.

#### **Annex A**

Request for waiver of the consideration of WDSF sanctioned events.

#### 2. Selection Criteria

Subject to the other considerations listed at paragraph 3 below, the following criteria shall be applied in the selection process:

- Athletes who have currently achieved at least <u>3rd placing</u> e.g., time/distance/score/mark of the 2021 SEA Games. For team sports, they should currently be ranked <u>3rd</u> among the SEA Games countries.
- Athletes/Teams who miss the qualifying standard marginally but show potential to equal or surpass it in time for the Games.
- All achievements submitted for consideration should have taken place at NSA sanctioned championships and trials, but NSAs may submit the achievements from overseas championships and meets of athletes studying in overseas tertiary institutions. However, these have to be properly accredited and sanctioned to be accepted.
- All achievements should be achieved from 1 April 2022 up to the Entry by Name deadline, which is likely to be in March 2023 (subject to local organizing committee's confirmation).
- Pursuant to the Olympic Charter (By laws to Rules 27 and 28, paragraph 2.1), "Selection shall
  be based not only on the sports performance of an athlete, but also on his ability to serve as
  an example to the sporting youth of his country."

Referring to SNOC's selection policy Para. 2 – Selection Criteria, the breaking committee wishes to request for the waiver from SGDF for the consideration of non-WDSF sanctioned events due to:

- 1) There is no breaking event in SEAG2021
- 2) Singapore breaking athletes have yet to compete in any WDSF sanctioned Breaking events (Outside of Singapore)
- 3) Limited breaking 1v1 events available for consideration (Events with SEA participants/competitors), held in Singapore.

At the time of this document, the only event held in Singapore that could potentially be considered under the requirements of SNOC, is 5 of A Kind Street Dance Festival (Held between 17 September 2022 - 18 September 2022), as it is the only local competition with a 1 v 1 category that had contestants from the SEA region. For list of contestants, please see Annex B.
